

Five brothers graduated in the fall semester and we wish them the best in their careers and life after college. We initiated 22 new members in the fall semester which was a little bit below our goal of 25 going into recruitment, however, all of the new brothers are high achievers and I believe they will be future leaders in the fraternity. I have not yet received the overall fraternity grade report from the university yet, but I am very pleased to announce that 22 brothers made the Dean's list last fall, and the majority of the brotherhood seemed to have successful semesters. Treasurer's Report

Be sure to put Saturday, February 23th on your calendar for our annual Sigma Pi Alumni Association meeting at the Players Retreat (PR) just off Hillsborough Street starting at 10:00 am. We will have a good meeting in a relaxed atmosphere and many of us will likely stay for Lunch afterwards.

We are continuing our push to grow the Alumni Association, and one of the best ways to help is for each of us to contact brothers from our era and get them involved. Many thanks to the 66 dues paying members that contributed in 2018 (See list below).

The amount in Alumni General Operations as of 08-02-18 totals \$229,642.20. Our General Operations are comprised of restricted funds of \$225,186.36 and unrestricted funds of \$4,455.84. The restricted funds are largely comprised of funds received from the sale of our Greek Way Lot and proceeds that the fraternity received from terminating its lease at their previous residence on Hillsborough St. To sell the lot we agreed to provide financing of \$75,000 to the buyer Nu Sigma Land Development, LLC (known as Phi Gamma Delta Fraternity). To date, Nu Sigma has repaid principal of

\$60,000 and has \$15,000 plus interest remaining that is due and payable. On 06/27/18, the board invested \$200,000 in a 12 month CD drawing 2.50%. We will continue to invest funds until we are able to purchase a new house for the actives.

I have attached a form that each alumnus can use to pay dues for 2019. If you have not already paid your dues for 2019, please complete the form and mail it back to me with a check. Also, you can pay us through pay pal. Simply go to the fraternity website at www.ncsusigmapi.com and click on alumni. We would like to build a cushion in the account to assist with the needs of maintaining and improving the appearance of the current fraternity house on Greek Way, and serve the house in the event that they need any proceeds to cover its operations. Your Alumni Association supports an active brotherhood, conducts the Annual Founder's Day Meeting at Players Retreat (PR) in February, and sponsors a Friday Night Homecoming Party in the fall for our Alumni to attend. If your name is not on the list, please consider giving. With all that said, we continue to have an aggressive goal of receiving dues from 100 alumni in 2019.
